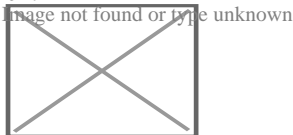

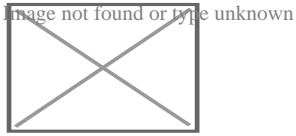

Renate S. Meissner und Christine Schwab receive award for services to the Republic of Austria

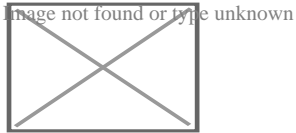
