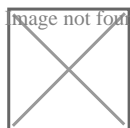

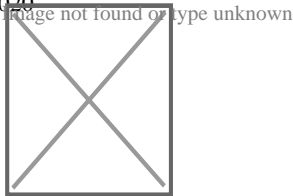
Arbitration Panel for In Rem Restitution dissolved upon acknowledgement of its Final Report
